IN 2022, DAKIN HUMANE SOCIETY PROVIDED SHELTER FOR 2,665 CATS, DOGS, AND SMALL ANIMALS. 1,970 ANIMALS WERE ADOPTED INTO NEW HOMES, 77 RETURNED TO THEIR FAMILIES, AND 115 TRANSFERRED TO OTHER AGENCIES.

ALL ANIMALS IN THE ADOPTION PROGRAM RECEIVE VACCINATIONS, SPAY OR NEUTER SURGERY, APPROPRIATE BLOOD TESTS FOR COMMON DISEASES, TREATMENT FOR INTERNAL/EXTERNAL PARASITES, AND MICROCHIP IDENTIFICATION. ANIMALS PRESENTING WITH A TREATABLE ILLNESS OR INJURY RECEIVE TREATMENT WHICH RANGES FROM CARE FOR COMMON RESPIRATORY DISEASE TO VARIOUS SURGERIES TO ADDRESS DENTAL OR ORTHOPEDIC ISSUES. (SEE SCH O)
